Având în vedere prevederile Ordonanței de urgență a Guvernului nr. 64/2007 privind datoria publică, cu modificările și completările ulterioare, coroborate cu cele ale capitolului IV din Legea nr. 273/2006 privind finanțele publice locale, cu modificările și completările ulterioare, precum și cu cele ale Hotărârii Guvernului nr. 9/2007 privind constituirea, componența și funcționarea Comisiei de autorizare a împrumuturilor locale, cu modificările și completările ulterioare;

Ținând seama de prevederile art. 43 alin. (4) din Legea nr. 24/2000 privind normele de tehnică legislativă pentru elaborarea actelor normative, republicată, cu modificările și completările ulterioare,

Luând în considerare prevederile art. 9 pct. 8 din Carta europeană a autonomiei locale, adoptată la Strasbourg la 15 octombrie 1985, ratificată prin Legea nr. 199/1997,

Ținând seama de prevederile art. 1166 și următoarele din Legea nr. 287/2009 privind Codul civil, republicată, cu modificările ulterioare, referitoare la contracte sau convenții,

Luând act de:

- b) raportul Serviciului financiar-contabil din cadrul aparatului de specialitate al primarului, înregistrat sub nr. 7818/23.05.2017;

- d)avizul nr.7819/23.05.2017 al secretarului orasului Breaza;

În temeiul prevederilor art. 36 alin. (2) și (4) lit. b), art. 45 alin. (2), art. 63 alin. (1) lit. c) și alin. (4) lit. c), precum și ale art. 115 alin. (1) lit. b), alin. (3), alin. (5) și alin. (6) din Legea administrației publice locale nr. 215/2001, republicată, cu modificările și completările ulterioare;

CONSILIUL LOCAL AL ORAȘULUI BREAZA adoptă prezenta hotărâre:

Art. 1. Se aprobă modificarea art.1 al HCL nr. 34/2016 în sensul restructurării creditului în sumă de 7.476.328,79 lei, cu o maturitate de la 10 ani la 15 ani, având scadență data de 22.05.2031.

Art.2. Se aprobă modificarea contractului de credit GRIM/949373/2016 din 19.05.2016 încheiat între orașul Breaza și UniCredit Bank București în sensul extinderii perioadei de grație până în Ianuarie 2018, conform graficului anexă la prezenta.

Art.3. Celelalte prevederi cuprinse în HCL nr. 34/2016 rămân nemodificate.

Art. 4. Prezenta hotărâre se comunică, prin intermediul secretarului orașului Breaza, în termenul prevăzut de lege, primarului orașului Breaza, Serviciului financiar-contabil, Serviciului PFI-API și Instituției Prefectului Prahova și se aduce la cunoștință publică prin publicarea pe pagina de internet a Primăriei orașului Breaza.

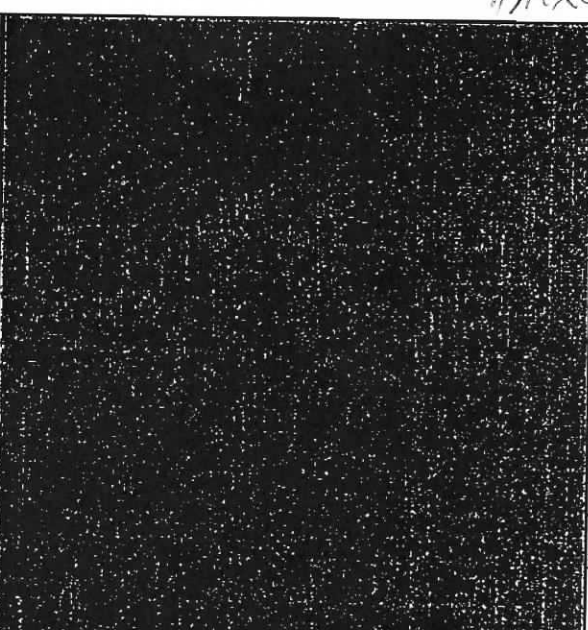
